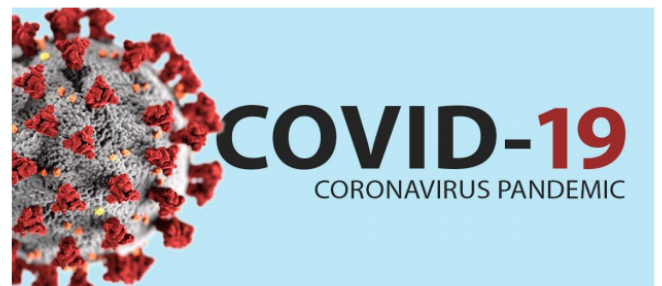

Utility Assistance Program



WINDY HILL FOUNDATION IS NOW OFFERING UTILITY ASSISTANCE FOR RESIDENTS AFFECTED BY COVID-19

Starting Monday, October 26, Windy Hill Community Residents who have been impacted financially by COVID-19 may qualify for limited financial assistance paying past due utility bills. Included utilities are water, electricity, and natural gas. (This program does not cover telephone, cable, or internet bills.)

Affected residents will be asked to provide proof of income, ongoing monthly expenses, their most recent utility bill(s), and verification that their past due balance is directly related to COVID-19.

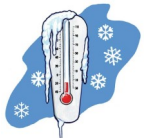
Angel Tree Program

The Salvation Army collects necessary information to determine qualification for participation in the program and details on each Angel. **Please have the following documents saved on your device to apply: photo ID, proof of residence (lease, utility bill or mail received from the school district or other government agency), child(ren's) birth certificate(s) proof of household income.**

No private information for you or your Angel is shared with the public. Donors will only be given a first name and Christmas wish list for each Angel.

Heating Assistance:

If you need help paying your fall and winter heating bills, you can apply for financial assistance through Loudoun County's Department of Family Services. To check eligibility or to apply, call (703) 777-0352 or visit www.commonhelp.virginia.gov

Applications due to the county by November 13

NEW! Virginia COVID-19 Energy Assistance Program: Households that would not typically qualify for other home energy assistance programs may be eligible to receive aid through the new Virginia COVID-19 Energy Assistance Program. The program is designed to assist low-income households who are not eligible to receive assistance from the existing energy assistance programs because they do not meet either the financial criteria or the vulnerable individual (household member who is age 60 or over/disabled/under age 6) criteria. Depending on the availability of funds, the program will provide a one-time payment of \$300 to assist eligible households with payment of a heating or cooling expense.

Applications are currently being accepted and will continue through November 20, 2020 or until funds are exhausted.

Eligibility criteria for assistance include:

- Must be resident of Virginia
- Must have a heating or cooling expense responsibility
- Must be either a United States citizen or an eligible immigrant
- A household's monthly gross income must be less than the maximum allowed for the number of people in the home
